Atlanta Graduate Chapter
By-Law XVII
Local Chapter Ordinances**

Ordinance 1

Sec. 1. This Chapter shall be known as the Atlanta Graduate Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of June 10th, 1954.

Ordinance 2

Sec. 1. The Chapter will verify any Member in question with The Central Office or Collegiate Chapter. The Chapter will request written or recorded proof of initiation into the Fraternity, and their status as a Member in good standing from their respective Collegiate or Graduate Chapter.

Sec. 1. Applicants must have two letters of recommendation from current Members of the Chapter.

Ordinance 4

The Officers of the Chapter and the Order of Election shall be: Regent, Vice-Regent, Secretary, Treasurer, Historian, Chaplain, Parliamentarian, Social Chair and Education Chair.

Ordinance 5

Sec. 1. Nominations of officers will occur at the meeting prior to the elections or in writing to the current Regent of the Chapter within one week prior to the elections. Officers shall hold office for a two-year period. Elections shall take place at the second meeting of the calendar year.

Ordinance 6

Sec. 1. The Regent shall make every attempt to attend all Chapter functions as well all Collegiate Chapter and general Fraternity events as possible. The Regent is also responsible for notifying all graduating Collegiate Members as well as any interested Graduate Members by letter to inform them of the purpose, activities, and responsibilities of the Chapter, and to invite them to become members. The Regent will also arrange the times and agenda, and lead the meetings.

Sec. 2. The Vice Regent is responsible for the production and distribution of the semiannual newsletter of the Chapter. The Vice Regent will also assume the duties of the Regent as needed.

Sec. 3. The Secretary shall take and distribute minutes to the membership of all the meetings and will receive and distribute all communications to and from The Central Office, and will supply the Regent with the names, addresses and phone numbers of all the dues-paying Members twice a year. The Secretary shall supply all pertinent information to the Regent within 48 hours of a meeting if unable to attend. Any and all information normally presented by the Secretary will be forwarded to the Regent. The Secretary will be responsible for contacting the Central Office to determine if a Member is in good standing.

Sec. 5. The Treasurer shall provide the Chapter with membership and financial information at all meetings, and a formal report of all financial information at least once a year, or upon request of the Regent.

Sub-Sec. C: The Legislative Committee shall be appointed by the Regent at the second meeting of the calendar year every other year coinciding with the election meeting. The committee shall consist of 3 members whose primary responsibility will be to review the Chapter By-Laws and Ordinances biannually and handle any legislative issues of the Chapter.

Sub-Sec. D: Members of the Scholarship Committee shall consist of the Executive Committee with the Scholarship Chairperson appointed by the Regent overseeing the Committee.

Sub-Sec. E: No additions to Sub-Sec. E of Sec. 5 of Uniform Graduate Chapter By-Law VII.

Sub-Sec. F: No additions to Sub-Sec. F of Sec. 5 of Uniform Graduate Chapter By-Law VII.

Sub-Sec. G: No additions to Sub-Sec. G of Sec. 5 of Uniform Graduate Chapter By-Law VII.

Sub-Sec. H: The Auditing Committee shall be appointed by the Regent at the second meeting of the calendar year every other year coinciding with the election meeting. The committee shall consist of the Secretary, Treasurer (non-voting member) and 3 other voting members.
