ORDINANCE 1 TITLE

Sec. 1. This Chapter shall be known as Beta Phi Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of February 12, 1927.

ORDINANCE 4 OFFICERS AND ORDER OF ELECTION

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, First Vice-Regent (Vice-Regent of Philanthropy), Second Vice-Regent (Vice-Regent of Fundraising), Secretary, Treasurer, Historian, Chaplain, Sergeant-at-Arms, two (2) Pledge Educators, two (2) Rush Chairs, Social Chair, and Grand Council Deputy. Officers of the Ritual may be appointed by the Regent.

ORDINANCE 5 QUALIFICATION, ELECTION AND INSTALLATION OF OFFICERS

Sec. 1. The nomination and election of Officers shall occur annually during the spring semester; these Officers shall serve until their successors are duly installed, unless removed from Office as stipulated in these By-Laws.

- Sec. 2. The duties of the First Vice-Regent (Vice-Regent of Philanthropy) shall include the planning of all philanthropic and community service events for the Chapter. The Vice-Regent of Philanthropy shall also plan events in accordance with the annual elected Province Philanthropy Challenge, and maintain records of Members' philanthropic contributions.

The duties of the Second Vice-Regent (Vice-Regent of Fundraising) shall include the planning of all fundraising events for the Chapter. The Vice-Regent of Fundraising shall also maintain records of Members' requests and payments for parking at the Chapter House.

In the event of the death, resignation, or removal of the Regent, the Vice-Regent of Philanthropy shall assume the office of Regent for the remainder of the term of office. The Vice-Regent of Fundraising shall then be the lone Vice-Regent. Likewise, should the office of Vice-Regent of Philanthropy become vacant for any reason, the Vice-Regent of Fundraising will also assume the role of the lone Vice-Regent.

- *Sec. 16.* The duties of the Social Chair shall consist of the planning of all social events hosted fully or in part by the Chapter. This includes, but is not limited to, all holiday parties, the College's Spring Formal, and the annual Chapter brotherhood retreat.

ORDINANCE 10 MEETINGS

Sec. 1. The regular meetings of the Chapter will be held every other week during the academic year on the day and time assigned by the College Tribunal. Any alterations to this schedule shall be at the discretion of the Regent. At least one (1) formal meeting per semester shall be held to conduct matters of business regarding the issuing of bids to prospective Members, the election of new Members, the election Officers, and any other topics deemed necessary by the Executive Committee.

Sec. 2. The Chapter shall issue a \$10 fine for persons absent from more than two (2) business meetings per academic semester and an additional \$10 for subsequent missed meetings, excluding

those taking part in College of Pharmacy facilitated functions. The Judiciary Committee may also warrant disciplinary action under By-Law IX if deemed as unethical conduct.

ORDINANCE 11 DUES

- Sec. 1. Newly elected Members shall be required to pay an initial dues assessment of \$110 that shall be collected at Initiation (which includes the fees set forth by the Grand Council and an additional \$15 for the Kappa Psi Plain Badge, and it to be paid to the Central Office within seven (7) days of Initiation). An additional dues assessment of fifty dollars (\$50) to be made by the end of the first academic year as a Member.
- Sec. 2. For subsequent professional years of study, each Member shall pay to the Treasurer one hundred fifty dollars (\$150), separated into two payments of seventy-five dollars (\$75) per academic semester. No dues need be collected in the fourth professional year of study. In the event that a Member is retained an additional year within the program of study, that Member is still responsible for payment of dues, given that they are not in their final year.
- Sec. 3. Special assessments may be imposed by a two-thirds (2/3) vote of the Chapter at any time. This includes, but is not limited to, the collection of payment for parking at the Chapter House, and participation in the annual brotherhood retreat.
- Sec. 4. Any Member delinquent in paying dues as decided by the Treasurer or Regent is subject to discipline by the Judiciary Committee and is deemed not in good standing within the Chapter, unless a written statement of financial constraint is submitted to both the Treasurer and Regent, in which case a payment plan may be instituted.
