Proposed chapter bylaws for UNE chapter of Kappa Psi.

By-Law XVII Delta Chi Chapter Ordinances

Ordinance 1. Title

- Sec 1. This chapter shall be known as Delta Chi Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of November 18th, 2011.

- Sec 1. Chapter Members shall abide by the applicable rules and policies of the University of New England pertaining to student organizations.

- Sec 1. To be eligible to pledge the Chapter, a person must fulfill the following requirements: Be a full time pharmacy student at the University of New England College of Pharmacy, be, at minimum, in their second semester of the Pharm D. program, and have an overall grade point average of 2.0. Those who meet these requirements can voluntarily choose to pledge the Chapter. Eligibility to be initiated into the Chapter will include successful completion of the following: three written examinations pertaining to information found in the Pledge Manual/pledge booklet as well as a final verbal interview and informational interviews with 80% of P2 and P3 members including all officers. Potential new members must also attend all required pledge meetings. The Regent and Vice Regent may change these requirements if they both feel it is necessary prior to the start of the pledge period.

Sec 1. The officers of the Chapter and Order of Election shall be: Regent, Vice Regent, Secretary, Treasurer, Historian, Chaplain, Sergeant-at-Arms, Pledge Trainer, Philanthropy Chair, Professionalism Chair and Grand Council Deputy.

Ordinance 5. Qualification, Election, and Installation of Officers

- Sec 1. Nomination of Officers shall take place at the first Chapter meeting following spring break with elections taking place at the following meeting.

- Sec 1. The duties of the Regent of the Chapter shall include, maintaining open communication lines with Province officers, National Officers, and the Central Office, checking the Chapter's email account weekly, communicating regional and national news to the Chapter, making sure all deadlines for forms are met, attending all Province and National meetings while in office, organizing, preparing, and submitting chapter of the year form in a timely manner, and reviewing the form from the previous year once per semester with the committee to establish improvements for the Chapter to work on. Other duties of the Regent include meeting with the treasurer and GCD to establish due dates for all membership dues and discuss Members in poor standing, and ensuring the use of ritual during meetings. The Regent shall serve as the Kappa Psi councilor to UNE student Government.
- Sec 2. The duties of the Vice Regent of the Chapter shall include: aiding the social chairs in preparing and planning rush events, organizing and overseeing all activities of or relating to Rush and the Pledge period. The Vice Regent must also aid the Regent in obtaining and organizing information for Chapter of the Year forms, and in preparing slide shows for chapter, regional, and national meetings.
- Sec 3. The duties of the Secretary shall include turning in all scholarship forms to the Central Office at the end of each semester, aiding the Regent in collecting chapter of the year information and maintaining the listservs.

- Sec16. The Professionalism Chair is responsible for developing programming for the chapter and college for professional development. This includes, but is not limited to, CV and Cover letter workshops, etiquette, different career opportunities, professional community events.
