Kappa Psi Pharmaceutical Fraternity Sullivan University, College of Pharmacy By-Law XVII: Local Chapter Ordinances

Ordinance 1 Title

Section 1. This Chapter shall be known as Epsilon Theta Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of October 24, 2009.

Section 2. This Chapter shall incorporate under the laws of the Commonwealth of Kentucky upon approval of its Incorporation Documents by the Grand Counselor.

Any student pursuing a doctorate degree in pharmacy that is enrolled at Sullivan University, College of Pharmacy is eligible for membership so long as he/she is in good academic standing (minimum cumulative grade point average of 2.0). Students may be eligible for election to membership after having successfully completed at least one quarter at Sullivan University College of Pharmacy. The pledge training shall be completed within three weeks.

Section 2. Upon completion of the pledge training, election to membership may occur at any meeting of the Chapter. The election of membership may be performed initially by means of secret ballot for the entire pledge class. An affirmative vote from 75% of active members who are eligible to vote entitles the entire pledge class to proceed into the initiation process of the Chapter. In the case that there are less than 75% of affirmative votes, the election of members shall be performed through secret ballot on an individual basis. Individuals must obtain at least 75% of affirmative votes from active members who are eligible to vote in order to proceed into the initiation process of the Chapter. Initiation will be determined by the Chapter, but should not exceed 30 days from the election of membership.

Section 1. The officers of this Chapter and Order of Election shall be: Regent, Vice Regent, Secretary, Treasurer, Historian, Chaplain, Sergeant-at-Arms and Grand Council Deputy(s).

Section 1. Nominations and election of officers shall occur in January of each year. Exiting officers shall mentor new officers as they assume their newly elected positions for the remainder of the quarter.
