# Ordinance 1

Sec. 1. This Chapter shall be known as the Maryland Graduate Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of October 2, 1971.

Graduate Members not residing or practicing within Maryland or final year collegiate members of a collegiate chapter not located within Maryland must also receive an affirmative vote from at least three fourths (3/4) of the Membership present at a regular meeting.

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, Vice Regent, Secretary, Treasurer, Chaplain, and Historian.

# **Ordinance 5**

Sec. 1. A call for election of Officers may be made by any Member in good standing of the Chapter and will be voted on at that meeting. Officers shall hold office for 12 months or until a call for election is requested as previously stated. Elections of Officers should occur at the next scheduled meeting of the Chapter. Said meeting must be no more than sixty (60) calendar days from the approved called for elections. All members in good standing are eligible for election, including student members in their final collegiate year.

If the election does not occur at a regular meeting, ballots may be submitted by other means provided the secrecy of the ballot is maintained and the platform utilized ensures that one member may only submit one ballot.
