Written reports of the expenses incurred shall be submitted to the Chapter immediately following such function.
- Sec. 17 The duties of the Graduate Liaison shall be comparable to the functions as indicated in the Constitution and By-Laws of the Fraternity as stated in the description of the Graduate Relations Committee.
- Sec. 18 The Faculty Advisor shall be a median between the faculty and administration of the school and the members of the Chapter.
