TITLE

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, Vice-Regent, Secretary-Treasurer, Historian, Chaplain, Social Coordinator, Sergeant-at-Arms and Scholarship Chairperson.

ORDINANCE 5

QUALIFICATION, ELECTION AND INSTALLATION OF OFFICERS

- Sec. 1. The nomination and election of officers shall occur as the first order of business during the meeting where the elections will take place. Officers shall hold office for a two-year period. Elections will take place during the first meeting of even numbered calendar years.

ORDINANCE 6

DUTIES OF OFFICERS

- Sec. 1. The Regent shall make every attempt to attend all Chapter functions and as many collegiate events as possible. The Regent shall also be responsible for sending a letter to all graduating collegiate members to inform them of the purpose and activities of the Chapter and invite them to become members.
- Sec. 2. The duties of the Vice-Regent shall include being responsible for the production and distribution of the semiannual newsletter of the Chapter.
- Sec. 3. The Secretary/Treasurer shall provide the Chapter with membership and financial information at all meetings as well as communication from the Central Office and supply the Regent with the names, addresses and phone numbers of all dues paying members twice per year. They shall inform the Regent within 48 hours of a meeting if unable to attend. Any information normally presented by the Secretary/Treasurer will be forwarded to the Regent. They shall also be responsible for contacting the Central Office to determine if a member is in good standing.

This officer shall also assist the Regent, when requested, with mailing and/or phone calling for upcoming meetings and events.
- Sec. 12. The Sergeant-at-Arms shall insure the secrecy of the Order during scheduled meetings. They shall also be responsible for the maintenance of the Risk Management Policy and serve as the Chair of the Chapter Risk Management Committee.
- Sec. 13. The Scholarship Chairperson shall maintain a record of available scholarships and their criteria for eligibility; maintain a record of recipients of each scholarship; keep accurate record of monies available in all accounts used to fund the scholarships; notify the Office of Students Services and the College of Pharmacy with his/her election to office, current address and phone number; maintain correspondence with the Office of Student Services on all matters pertaining to Kappa Psi Scholarships and awards; obtain a list of all eligible Kappa Psi collegiate members' scholarships or awards chosen by the Scholarships, Fellowships and Awards Committee at the College of Pharmacy; notify eligible students for scholarships who recipients are chosen by the Executive Committee; acknowledge all recipients of scholarships/awards as described in each; and inform the Chapter members of the recipients.

Sub-Sec. E. Members of the Scholarship Committee shall be the Executive Committee with the Scholarship Chairperson overseeing the Committee.

Sub-Sec. F. No additions to By-Law VII, Sec 5, Sub-Sec F, of the Uniform Graduate Chapter By-Laws.
