ORDINANCE 1

TITLE

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, Vice-Regent, Secretary-Treasurer, Historian, Chaplain, Social Coordinator, Sergeant-at-Arms and Scholarship Chairperson.

ORDINANCE 5

QUALIFICATION, ELECTION AND INSTALLATION OF OFFICERS

- Sec. 1. The nomination and election of officers will occur as the first order of business during the meeting where the election will take place. Officers shall hold office for a two-year period. Elections will take place during the first meeting of the calendar year of even years.

ORDINANCE 6

DUTIES OF OFFICERS

- Sec. 1. The Regent shall make every attempt to attend all Chapter functions along with as many collegiate events as possible, or encourage other Graduate Brothers to attend collegiate events in his/her absence. The Regent is also responsible for sending a letter to all graduating collegiate members to inform them of the purpose and activities of the Chapter and also to invite them to become members. The Regent shall appoint a Webmaster to manage the Nebraska Graduate Chapter webpage.
- Sec. 2. The Vice-Regent is responsible for the production and distribution of the biannual newsletter of the Chapter.
- Sec. 3. The Secretary/Treasurer shall provide the Chapter with membership and financial information at all meetings as well as communication from the Central Office and supply the Regent with the names, addresses and phone numbers of all dues paying members twice a year. The Secretary/Treasurer shall inform the Regent within 48 hours of a meeting if unable to attend. Any information normally presented by the Secretary/Treasurer will be forwarded to the Regent.

- Sec. 11. The Social coordinator shall coordinate group social activities. This shall include the annual summer event. Duties will consist of location arrangements and food planning when requested. This officer shall also assist the Regent, when requested, with mailings and/or phone calling for upcoming meetings and events.
- Sec. 12. The Sergeant-at-Arms shall insure the secrecy of the Order during scheduled meetings. They will also be responsible for the maintenance of the Risk Management Policy and serve as the chair of the Chapter Risk Management Committee.
- Sec. 13. The Scholarship Chairperson shall maintain a record of available scholarships and their criteria for eligibility; maintain a record of recipients of each scholarship; keep accurate record of monies available in all accounts used to fund the scholarships; obtain a list of all eligible Kappa Psi collegiate members' scholarships or awards; notify eligible students for scholarships whose recipients are chosen by the Executive committee; acknowledge all recipients of scholarships/awards as described in each; and inform the Chapter members of the scholarship/award recipients.

- Sub-Sec. D. Members of the Scholarship Committee shall be the Executive Committee with the Scholarship Chairperson overseeing this Committee.
- Sub-Sec. E. No additions to By-Law VII, Sec 5, Sub-Sec E, of the Uniform Graduate Chapter By-Laws.
