The Chapter will not deny membership on the basis of race, sex, age, disability, veteran status, religion, sexual orientation, color, or national origin.

Ordinance 9

Sec. 1. If the reason for disciplinary action is refusal to pay dues, the following requirements must be met: The member must (1) have not paid dues by the date announced by the Executive Committee, (2) have not paid dues after receiving a reminder (via email) from Secretary, Treasurer, or Regent of their delinquency, (3) and has not provided the Regent with reasonable circumstance in which the Member cannot pay dues. If all above requirements have been met, then the Secretary, Treasurer, or Regent will contact the Member and inform them (via email) of the date that their hearing shall be held. If dues are not paid by this time, the Chapter may proceed with the hearing according to the Constitution and By-Laws of the Fraternity. In event of a conviction on the grounds of refusal to pay dues, the unanswered email correspondences described above will serve as the written testimony.
