

By-Law XVII - Local Chapter Ordinances

Zeta Mu Chapter

Ordinance 1

Sec. 1. This chapter shall be known as Zeta Mu Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of June 13th, 2013.

Sec. 2. There shall be two secret ballot elections during the pledge semester. The first election, the pledge must receive one-half of the chapter votes in order to continue towards membership and this shall occur at the mid-point of the pledge process. The second election, the pledge must receive three-fourths of the chapter votes in order to go through the Initiation Ceremony as set forth in the Ritual of the Fraternity.
