

Uniform Collegiate Chapter By-Law XVII

Local Chapter Ordinances

Epsilon Sigma Chapter

Ordinance 1: Title

Sec. 1. This chapter shall be known as Epsilon Sigma Chapter, hereinafter referred to as the Chapter, of Kappa Psi Pharmaceutical Fraternity, Incorporated, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of February 25th, 2012.

Sec. 1. Persons shall be proposed for membership if they are enrolled in the doctorate of pharmacy program or are pharmacy faculty at the University of Florida, College of Pharmacy, St. Petersburg, Florida campus. Only pledges that have met the requirements established by the Chapter for the pledge period shall be offered membership in the Chapter.

Ordinance 4: Officers and Order of Election

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, 1st Vice-Regent, 2nd Vice-Regent, Secretary, Treasurer, Historian, Chaplain, Pledgemaster, Sergeant-at-Arms, Grand Council Deputy and Co-Grand Council Deputy.

Ordinance 5: Qualification, Election and Installation of Officers

Sec. 1. The nomination and election of Officers shall occur annually at the last business meeting of the academic year. Only Members who have been in the fraternity for one full year at the time of election, and have served as a chapter officer, may be eligible for the office of Regent, 1st Vice-Regent and 2nd Vice-Regent. Only Members who have been in the fraternity for one full year may be eligible for the offices of Secretary and Chaplain.

Ordinance 10: Meetings

Sec. 1. Regular meeting of the chapter shall be held twice a month starting at the beginning of the academic year. The time and date of the first meeting of the academic year shall be decided at the last regular meeting of the previous academic year. All other meeting times and dates for the year shall be decided at the first regular meeting of the academic year.

Sec. 2. A fine of five dollars (U.S.) (\$5.00) may be levied for unexcused absence from any regular meeting. Excused absences may include, but are not limited to illness, family issues or academic requirements. All excused absences must be approved by the Regent as soon as possible to avoid the fine. Students in their fourth academic year (P4) who are on advanced pharmacy practice experiences (APPEs) will not be subject to fines for missed meetings.

Ordinance 11: Dues

Sec. 1. Each newly elected Member shall pay to the Treasurer Initiation fee of one-hundred thirty dollars (U.S.) (\$130.00) for their first year of membership. This fee shall be divided as follows: forty-five dollars (U.S.) (\$45.00) to the Central Office for Grand Council Membership Fee, twenty dollars (U.S.) (\$20.00) to the Central Office for second semester Grand Council Dues, seven dollars (U.S.) (\$7.00) to Province Dues, eight dollars (U.S.) (\$8.00) to the Chapter Grand Council Convention Fund, fifty dollars (U.S.) (\$50.00) towards the Chapter Treasury. Such funds as are due to the Grand Council shall be transmitted to The Central Office within seven (7) days of initiation.

Sec. 2. Dues for the chapter shall be one hundred dollars (U.S.) (\$100.00) for each year after the initiation year. To be divided as follows: forty dollars (U.S.) (\$40.00) to the Central Office for Grand Council Dues, seven dollars (U.S.) (\$7.00) to Province Dues, eight dollars (U.S.) (\$8.00) to the Chapter Grand Council Convention Fund, twenty-five dollars (U.S.) (\$45.00) towards the Chapter Treasury.
