Uniform Collegiate Chapter Local Ordinances

Ordinance 1: Title

Sec. 1. This chapter shall be known as Epsilon Xi Chapter, hereinafter referred to as the Chapter, of Kappa Psi Pharmaceutical Fraternity, Incorporated, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of February 5, 2011.
