ORDINANCE 1

TITLE

Sec. 1. This Chapter shall be known as North Florida Graduate Chapter, hereinafter referred to as the Chapter, according to the Charter granted by Alpha Chapter of Kappa Psi Pharmaceutical Fraternity, Incorporated, hereinafter referred to as the Fraternity, under the date of August 7th, 2007.

Sec. 1. The Chapter will verify any Brother in question with the Central Office or collegiate Chapter. The Chapter will request written or recorded proof of initiation into Kappa Psi and their status as a Brother in good standing from their respective collegiate or Graduate Chapter.

OFFICERS AND ORDER OF ELECTION

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, Vice-Regent, Secretary, Treasurer, Historian, Chaplain and Parliamentarian.

ORDINANCE 5

QUALIFICATION, ELECTION AND INSTALLATION OF OFFICERS

Sec. 1. The nomination and election of officers shall occur at the meeting prior to the elections or in writing to the current Regent of the Chapter within one week prior to elections. Officers shall hold office for a two year period. Elections shall take place at the second meeting of the calendar year.

ORDINANCE 6

DUTIES OF OFFICERS

Sec. 1. The Regent shall make every attempt to attend all Chapter functions as well as all Collegiate Chapter and general Fraternity events as possible. The Regent is also responsible for notifying all graduating Collegiate Members, as well as any interested Graduate Members, by letter, to inform them of the purpose, activities, and responsibilities of the Chapter, and to invite them to become Members. The Regent will also arrange the times and agenda, and lead the meetings.

Sec. 2. The Vice-Regent is responsible for the production and distribution of the semiannual newsletter of the Chapter. The Vice-Regent will also assume the duties of the Regent, as needed.

Sec. 3. The Secretary shall take and distribute minutes to the membership of all the meetings and will receive and distribute all communications to and from The Central Office, and will supply the Regent with the names, addresses and phone numbers of all the dues-paying Members twice a year. The Secretary shall supply all pertinent information to the Regent within forty-eight (48) hours of a meeting if unable to attend. Any and all information normally presented by the Secretary will be forwarded to the Regent. The Secretary will be responsible for contacting the Central Office to determine if a member is in good standing.

The committee shall consist of 3 members whose primary responsibility will be to review the Chapter By-Laws and Ordinances biannually and handle any legislative issues of the Chapter.

Sub-Sec. D. Members of the Scholarship Committee shall consist of the Executive Committee with the Scholarship Chairperson appointed by the Regent overseeing this committee.
