ORDINANCE 1

TITLE

Sec. 1. The Officers of the Chapter and Order of Election shall be: Regent, Vice-Regent, Secretary-Treasurer, Historian, Chaplain and Sergeant-at-Arms.

QUALIFICATION, ELECTION AND INSTALLATION OF OFFICERS

Sec. 1. The nomination and election of officers will occur as the first order of business during the meeting where the election will take place. Officers shall hold office for a two-year period. Elections will take place during the April meeting of the even calendar years.

ORDINANCE 6

DUTIES OF OFFICERS

Sec. 1. The Regent shall make every attempt to attend all Chapter functions along with as many collegiate events as possible, or encourage other Graduate Brothers to attend collegiate events in his/her absence. The Regent is also responsible for sending a letter to all graduating collegiate members to inform them of the purpose and activities of the Chapter and also to invite them to become members. The Regent shall appoint a Webmaster to manage the South Dakota Graduate Chapter webpage.

Sec. 2. The Vice-Regent is responsible for the production and distribution of the biannual newsletter of the Chapter.

Sec. 3. The Secretary/Treasurer shall provide the Chapter with membership and financial information at all meetings as well as communication from the Central Office and supply the Regent with the names, addresses and phone numbers of all dues paying members twice a year. The Secretary/Treasurer shall inform the Regent within 48 hours of a meeting if unable to attend. Any information normally presented by the Secretary/Treasurer will be forwarded to the Regent.
